Lee Swain, Bureau Veritas explained how their long-time company works with small municipalities, discussed the combo building inspection/ electrical inspection/plumbing set up works, as opposed to a single certification many inspectors have. Council asked about rates, and he discussed those. Jon said that's more than what we charge for our building permits, but that could be increased to cover the inspection services. Jon thought the set up would streamline the city's inspection process. Billy said he wanted to consider another person.
