1. **Call to Order:** Call regular council meeting to order and establish a quorum.

3. **Consider and Act** to approve Council minutes for February 12, 2019 and February 25, 2019.
4. **Consider and approve** February 2019 Financials and disbursements
5. **Citizen Comments:** Sign up and submit forms prior to meeting to City Secretary

Citizens may speak 3 minutes per person each on matters, other than personnel, concerning the City. There is no transfer of time to others allowed. Citizens must sign in on the Citizen Comments form furnished by the City. City of Post Oak Bend action in response to or as result of such statements may not be undertaken until such matters on a City Council agenda published in accordance with the Texas Open Meetings Act, and acted upon accordingly at such meeting. Citizens must furnish their name, address, and whether or not they reside within the City of Post Oak Bend before addressing Council or P&Z Commission under this item.

10. Discuss and approve Request for Proposal (RFP) for city trash collection single user
11. Approve amendment to 2018 budget on reserve funds expenses
12. Discuss and approve approving Kaufman County Development office to regulate proposed ETJ subdivision plat on FM 987 with input from City (Section 242.001 (d), Local Government Code)
13. Discuss and Act on subdivision homeowner's failure to obtain city approval, failure to provide required building plans, failure to obtain permit for home addition, pipe drain
14. Discuss and make recommendation on placement of "Tiny House" structure on property to be purchased on County Road 280 and Bureau Veritas and City Building Code requirements
